This contract focuses on the most critical elements for new drivers— the things that will keep them safe and sound. It is brief and ready for you to use as you see fit. Feel free to share it with other parents as well.

This contract is a powerful tool used on its own, but when you combine it with RideBeside's monitoring system, you have an incredible framework to raise a safe and thoughtful young driver.

I will always observe the Speed Limit.  Speeding is a factor in 1 out of every 3 teen driving fatalities	☐ I will lose my driving privileges for days/weeks☐ I will pay for all fines and fulfill all penalties by law☐
